Gentlemen:

At a house meeting, Grove House voted by 96 percent to endorse the demands of the April 3rd Coalition asking for an end to all chemical and biological warfare, counter-insurgency, classified, and war-related research on the Stanford campus and at SRI, and for bringing SRI under closer control of the university, and for an open decision-making meeting of the trustees to decide the future status of SRI. Grove House also voted by 70 percent to endorse the tactic of the sit-in.

Lambda Nu - Statement of Support

As a public expression of our commitment to peace and the creation of a more humane world, we, the members of Lambda Nu, declare the following:

1. We support the goals and demands of the April 3rd Coalition. We ask that counterinsurgency; biological, chemical and radiological warfare research, and all other war-related and classified research being conducted on the Stanford campus and at the Stanford Research Institute cease and that the university recommit itself to the causes of peace and human welfare. 94%
2. We support the tactics approved by the April 3rd Coalition as long as those tactics remain peaceful and democratically formulated. 68%
3. We will contribute \$50 of house funds to help defray the expenses incurred during the progress of the sit-in. 70%
4. We also ask for general amnesty for all those participating in the sit-in. 86%

WE, THE RESIDENTS OF CARDINAL HOUSE, FLORENCE MOORE HALL, HEREBY EXPRESS OUR SOLIDARITY WITH THE MEMBERS OF THE APRIL THIRD COALITION AND OUR STRONG BELIEF IN THE URGENCY WITH WHICH ITS DEMANDS MUST BE IMPLEMENTED;

WE WHOLEHEARTEDLY ENDORSE THE COALITION'S DEMANDS THAT CBW, COUNTERINSURGENCY, CLASSIFIED, AND WAR-RELATED RESEARCH BEING DONE EITHER ON THE STANFORD CAMPUS OR AT SRI BE DISCONTINUED IMMEDIATELY;
