## REPORT ON COMMITTEE ACTION

SRI Committee -- The Committee has contacted SRI employees who are gathering to discuss issues raised by the Coalition as well as problems they face as employees, i.e., problems of political suppression by the management. The Committee is very interested in making the Coalition information available to all SRI employees; however, at this time, it seems more important that the employees move on their own. Therefore we will not attempt to leaflet at this time. We will meet Monday with representatives of the SRI group.

Industrial Park Committee -- The Committee has contacted an employee of Varian Electronics who is going to form a seminar there. The leaflet to be handed out at lunch and as the employees leave has been written and printed. A committee meeting to consider acceptance of the leaflet was held in the Malcolm X Room (formerly Rambo's office) Sunday afternoon. Those interested in leafleting should meet on Monday at 10:00 in the Malcolm X Room.

Community Liason Committee -- The Committee has leafleted downtown Palo Alto shopping districts, movie theaters, street intersections, churches. Seven ministers have invited congregations to the sit-in, especially yesterday's tea and symposium. The 1st Presbyterian Church is hold9ng a panel discussion on ethical and social problems surrounding scientific research and national defense, in particular as this applies to our current movement.

Life Sciences Caucus -- The gunn group met Sunday at 1:00.

Guidelines Committee -- The Review Board Council and Review Board and Guidelines

Committee met today together to consider guidelines revisions. Harry Cleaver and Steve
Weissman discussed the forthcoming minority report of the SRI, and it was agreed to incomporate certain salient features into the guidelines, particularly a more detailed explication of the political nature of research now being done at Stanford and SRI, and the political orientation we desire. Revisions were presented at last evening's meeting."

A fulller explanation of the relation of our demands and guidelines to basic principles of academic freedom is being written. The Review Board will be more clearly asked to be responsible for regular publications of abstracts and contracts proposed. The word 'exception' will be deleted from the sections onclassfied research and an appeals process substituted. The Committee met last night at 9:30, and caucuses will meet in Trisidder Monday at 4:15 to discuss positive research proposals in the various disciplines.

Press Committee -- The central organization of the Press Committee is the April 3
Movement News Service on the second floor, which handles press retations 24 hours a day, and also attempts to facilitate comm nication within the community here. Groups holding meetings are asked to post t mes and places on the bulletin board at second floor head-quarters and also in the Eldridge Cleaver Lounge (Room 224). The Committee needs the following sorts of workers: receptionist, interviewers, reporters, writers, typists, crowd estimators.
