## WARRANTS ISSUED

Complaints have been filed by private citizens, SRI employees, and Stanford students (YAFers) stemming from the Friday (May 16th) demonstration at SRI/ Hanover. Charges filed include arson, battery, riot, failure to disperse, and remaining at the scene of a riot. Some warrants have been issued by the Santa Clara district attorney—the exact number is not known. According to one source, arrests are not likely until tomorrow, but if you are arrested tonight call our legal defense at 328-4941—if no answer call 321-2434.
