shall have the duty of - (A) receiving and examining reports of the Comptroller General of the United States and of submitting such recommendations to the Senate as it deems necessary or desirable in connection with the subject matter of such reports; (B) studying the operation of Government activities at all levels with a view to determining its economy and efficiency; (C) evaluating the effects of laws enacted to reorganize the legislative and executive branches of the Government; (D) studying intergovernmental relationships between the United States and municipalities, and between the United States and international organizations of which the United States is a member."
